CERTIFICATION OVERVIEW & CURRICULUM

ICEA Certified Postpartum Doula requirements are a means of documenting the journey every postpartum doula should achieve to maintain and update family support skills following a birth. Regardless of the candidate's background, each one will find that every part of the ICEA Postpartum Doula Certification program will build their current level of knowledge and skills to be the best postpartum doula possible. An ICEA Certified Postpartum Doula (ICPD) is internationally recognized as a professional doula in every sense of the word. Candidates can proudly use the ICPD credentials anywhere.

The ICEA Postpartum Doula Certification Program verifies that Postpartum Doulas have the necessary education and skills to enable them to facilitate families after labor. The program promotes the concept of the Postpartum Doula as an advocate of the natural process of childbirth and the right of the expectant parent to make informed decisions based on knowledge of alternatives. Following is the program curriculum:

- Part I – ICEA and the Postpartum Doula Certification
- Part II – Mother's Physical Recovery
- Part III – Postpartum Emotions
- Part IV – Family Dynamics
- Part V – Newborn Appearance
- Part VI – Baby Care
- Part VII – Breastfeeding
- Part VIII – Listening and Communication Skills
- Part IX: – Business Aspects and Responsibilities
- Part X – Replenishing the Doula Spirit – Maintaining the Passion

The ICEA Postpartum Doula is expected to further a wider understanding of ICEA's mission and philosophy among health professionals and the public.

Experienced Pathway Steps to Certification

The following steps must be completed within two years of enrolling in the program. Candidates must FIRST enroll in the certification program before completing the other steps.

1. Enroll in the certification program
2. Review the certification study guide and the referenced readings (optional)
3. Study specific ICEA position papers and pass post-tests (provided after enrollment)
4. Confirm current Infant/Baby/Adult CPR Certification
5. Apply to take the certification examination
6. Submit proof of current or prior certification (no more than two years expired) with ICEA or another organization along with the examination application form



Candidate Qualifications

This certification program is available to any postpartum doula who upholds and practices ICEA's philosophy of family-centered maternity care and freedom to make decisions based on knowledge of alternatives in childbirth. This program does not exclude an otherwise qualified person for reason of educational or professional background. No qualified, presently certified postpartum doula will be excluded from entering the ICEA Postpartum Doula Certification Program.

The Examination

The ICEA Postpartum Doula Certification examination is designed to test for a thorough knowledge of the basic content in being a postpartum doula. The examination is based solely on the objectives outlined in the ten parts of the ICEA Postpartum Doula curriculum.

The examination consists entirely of 75 multiple choice questions. There are no short answer or essay questions. The examination is "closed book" and must be proctored. 1.5 hours is given to complete the examination. The score is based on the number of correct answers.

Candidates for whom English is a second language must contact the office as an examination may be available in their primary language. If an examination is not available in their primary language, then candidates may use a non-medical primary language/English dictionary and 2.5 hours to complete the examination. The ICEA Central Office must be notified, in writing, of these special needs at the time the certification examination application and fee are submitted.

Applying to Take the Examination

Candidates have up to two years, from the date in which they enrolled in the program, to complete the examination pre-requisites and apply for the examination. If more than two years pass, candidates must re-enroll in the program and again complete all the pre-requisites. Examination applications will not be accepted unless they are complete. A complete application includes all needed forms and verifications, examination date, location and proctor, and full payment.



Scheduling Your Examination

All examinations are given online but must be taken with a proctor in person at the testing location chosen by the candidate. Candidates may apply to take the examination in any state, province or country, and are not limited to taking the examination in their local geographic area. An examination can be scheduled by completing and submitting the ICEA Postpartum Doula Certification Examination Application. All examinations must be scheduled at least 30 days prior to the examination date. This includes any requested changes in scheduled examinations. The online link for the candidate's exam will be emailed to the proctor in advance of the testing date.

Grading of the Examination

Because every examination is taken through an online program, candidates will immediately know their results upon completion. Each candidate who receives a passing score of 70% or above is considered to be an ICEA Certified Postpartum Doula, an ICPD. ICEA will issue a formal certificate via email to those who have successfully completed the program. A three-year ICEA membership will be provided along with the certification.

In the event a candidate fails the exam, ICEA will send the candidate a new examination application via email to retake the test. These candidates will have up to one year in which to pass the examination. They may retake the examination as many times as necessary within one year of the first fail date, providing repeat guidelines are followed and ICEA membership is maintained. Examinations ruled invalid will be treated as failed examinations and the candidate will have one year to retake the examination per guidelines. Each subsequent exam will be charged a fee based on geographic location.

Certification Designation

Upon successful completion of the ICEA Postpartum Doula, a doula will be entitled to use ICPD and the term "ICEA Certified Postpartum Doula" to designate certification status and to indicate that the postpartum doula is ICEA Certified.

Recertification

ICEA is dedicated to maintaining a rigorous standard of excellence, and thus all ICEA certifications are only valid for three years. At the completion of the three years, all ICEA Certified Postpartum Doulas must apply for recertification.

ICEA believes that postpartum doulas are continually educating themselves and learning from their clients. Recertification validates commitment to the profession and ensures the continuation of receiving the benefits of ICEA affiliation.

Extension of the Recertification Application Deadline

An ICD may apply for a single 6-month extension of the recertification deadline in order to complete the requirements. The request for an extension must be received before the recertification application deadline. The request must be in writing via email and state why the extension is needed. The request must also be received prior to the certification expiration date. The ICEA Certification Coordinator will respond in writing via email that the extension has been granted. The extension is only for submitting the application. The next certification period expiration date is based on the date of initial certification.



Inactive Status

ICDs who encounter a family emergency including serious illness, illness or death of a close family member, divorce, major relocation, birth of a baby, or who have temporarily left the field may request to be put on Inactive Status for a maximum of three years. The request for inactive status must be received by the expiration of the current certification period. The request must be in writing via email and state why the inactive status is needed. The ICEA Certification Coordinator will respond via email that the inactive status has been granted. Only one inactive status will be granted per certification period. An inactive status fee will need to be paid when the individual decides to go inactive and a recertification fee will need to be paid to become active again.

Lapsed Certification

An ICD with a lapsed certification of more than 6 months may reinstate to full certified status by completing the experienced pathway toward certification. The reinstated certification period begins when the individual has passed the certification examination.

ICEA reserves the right to change any part of the certification program or recertification process without notice. Notice of such changes will be sent in the newsletter, ICEA Connection.



POSITION PAPERS

The purpose of studying specific ICEA Position Papers and passing their corresponding Posts Tests is to assess a candidate's familiarity with current, evidence-based information.
